## INSTRUCTIONS FOR COMPLETING THE USMCA CERTIFICATION OF ORIGIN

For purposes of obtaining preferential tariff treatment, this document must be completed legibly and in full, and be in the possession of the importer at the time the declaration is made. This document may be completed by the importer, exporter, or producer.

<b>BLANKET PERIOD</b>	Indicate the duration of the Certificate. The blanket period cannot exceed a period of one calendar year.
<b>1. CERTIFIER</b>	Provide the Certifier's company name, address (including country), and e-mail address
<b>2. EXPORTER</b>	Provide the Exporter's name, address (including country), e-mail address, and telephone number if different from the certifier. This information is not required if the producer is completing the certification of origin and does not know the identity of the exporter; state "Unknown." The address of the exporter shall be the place of export of the good in a Party's territory. If the information is the same as the Certifier, state "Same as Certifier."
<b>3. PRODUCER</b>	Provide the Producer's name, address (including country), e-mail address, and telephone number, if different from the certifier or exporter. If there are multiple producers, state "Various" or provide a list of producers. If this information is to remain confidential, state "Available upon request by the importing authorities". The address of a producer shall be the place of production of the good in a Party's territory. If the information is the same as the Certifier, state "Same as Certifier."
<b>4. IMPORTER</b>	Provide, if known, the Importer's name, address, e-mail address, and telephone number. The address of the importer shall be in a Party's territory. If the importer name and address are not known, state "Unknown."
<b>5. DESCRIPTION</b>	Provide a description of the good. The description should be sufficient to relate it to the good covered by the certification.
<b>6. HTS</b>	Provide the Harmonized Tariff Schedule classification to the 6-digit level for each good described in Field 5
<b>7.
